DRAFT 0361	13221/2023	AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY, FOR AND ON BEHALF OF THE CITY OF WARREN, TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACT(S) FOR THE DESIGN, PROJECT MANAGEMENT, AND INSTALLATION OF PUMP REPLACEMENT, INCLUDING BUT NOT LIMITED TO ELECTRICAL WORK, CONTROL PANELS, SPRINKLER BOXES, AND ALL REQUIRED APPURTENANCES THERETO, FOR THE AVALON SOUTH GOLF COURSE, AND DECLARING AN EMERGENCY.
