AN ORDINANCE FOR THE PURPOSE OF APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED REVENUE OF VARIOUS CITY FUNDS, APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED REVENUE OF THE GENERAL FUND, TRANSFERRING WITHIN CERTAIN CITY FUNDS, APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED BALANCES OF VARIOUS CITY FUNDS, APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED BALANCE OF THE GENERAL FUND, AND DECLARING AN EMERGENCY.

WHEREAS, there exists a need to appropriate from the unappropriated, anticipated revenue of various city funds, to appropriate from the unappropriated, anticipated revenue of the general fund, to transfer within certain city funds, to appropriate from the unappropriated, unencumbered balance of various city funds, and to appropriate from the unappropriated, unencumbered balances of the general fund.

WHEREAS, this Ordinance constitutes an emergency measure, in part, in that the same provides for the usual daily operation of the municipal departments; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That there be, and hereby are, appropriated from the unappropriated, anticipated revenue of various city funds, the sums as follows:
