DRAFT 0402	13255-2023	AN ORDINANCE AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY PURSUANT TO SECTION 721.15(C) OF THE OHIO REVISED CODE TO DISCARD MUNICIPALLY-OWNED PERSONAL PROPERTY THAT IS NO LONGER NEEDED FOR ANY MUNICIPAL PURPOSE OR PUBLIC USE, OR IS OBSOLETE, OR IS UNFIT FOR ANY MUNICIPAL PURPOSE OR PUBLIC USE AND HAS NO VALUE, AND DECLARING AN EMERGENCY.
