DRAFT 0468	13313/2024	AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE AND SAFETY, FOR AND ON BEHALF OF THE CITY OF WARREN, TO ENTER INTO A TEMPORARY EASEMENT AGREEMENT WITH WARREN FABRICATING AND MACHINING FOR CHAMPION METER PIT UPGRADES, PURSUANT TO THE LEGAL DESCRIPTION ATTACHED AS EXHIBIT "A," AND DECLARING AN EMERGENCY.
