**THE FOLLOWING LEGISLATION WAS PASSED BY COUNCIL ON THE 9<sup>TH</sup> DAY OF JANUARY 2019.**

<b>3820</b>	<b>12833/19</b>	An ordinance authorizing the Director of Public Service and Safety, on behalf of the City of Warren, to enter into an agreement(s) with the Director of the Ohio Department of Natural Resources, and any other agreement(s) and/or contract(s), which may be necessary or useful for the restoration of the Quinby Park Shelter House, and declaring an emergency.
<b>3821</b>	<b>12834/19</b>	An ordinance authorizing the Mayor and the Director of Public Service and Safety, for and on behalf of the City of Warren, Ohio, to enter into a contract(s) for the construction of necessary improvements at the Water Pollution Control Center known as the PST/Clarifer early action project of the Water Pollution Control Facility Refurbishment Project, and declaring an emergency.
<b>3822</b>	<b>12835/19</b>	An ordinance authorizing the payment of specific orders or contracts upon receipt of the certification of the Fiscal Officer of the sufficiency of funds for said expenditures, and declaring an emergency.
<b>3823</b>	<b>12836/19</b>	An ordinance authorizing the Mayor and the Director of Public Service and Safety, for and on behalf of the City of Warren, Ohio to enter into an agreement with Trumbull County (hereinafter referred to as “Trumbull County 911” for three (3) years, with three (3) mutually agreed upon renewal option terms of three (3) years per term for the purpose of receiving, dispatching and relaying calls to various political subdivisions and public safety responders during the year 2019 and declaring an emergency.
<b>3825</b>	<b>12837/19</b>	An ordinance authorizing the Director of Public Service and Safety to enter into agreement(s) with the Director of the Ohio Department of Transportation, and any other agreement(s) and/or contract(s) which may be necessary or useful, for the engineering, planning and construction of the Harmon Avenue sidewalks project, and declaring an emergency.
<b>3826</b>	<b>12838/19</b>	An ordinance authorizing the Director of Public Service and Safety to enter into agreement(s) with the Director of the Ohio Department of Transportation, and any other agreement(s) and/or contract(s) which may be necessary or useful, for the engineering, planning and construction of the Warren Signals Project, and declaring an emergency.
<b>3827</b>	<b>12839/19</b>	An ordinance authorizing the Director of Public Service and Safety to enter into agreement(s) with the Director of the Ohio Department of Transportation, and any other agreement(s) and/or contract(s) which may be necessary or useful, for the engineering, planning and construction of the Warren Safe Routes to School Project, and declaring an emergency.
