TITLE

AN ORDINANCE FOR THE PURPOSE OF REPEALING WATER POLLUTION CONTROL CAPITAL EXPENDITURES, SUPPLIES, CONTRACTED SERVICES AND DEBT SERVICE AS APPROPRIATED FROM THE UNAPPROPRIATED, UNENCUMBERED 2018 BALANCES OF CERTAIN CITY FUNDS AS LISTED UNDER SECTION 1 OF ORDINANCE NO. 12861/19 PASSED ON APRIL 10, 2019 AND DECLARING AN EMERGENCY.

WHEREAS, on April 10, 2019, Ordinance No. 12861/19 was passed by this Council and included the following, which was appropriated from the unappropriated, unencumbered 2018 balances of certain City funds; and

WHEREAS, it is necessary to repeal said Water Pollution Control capital expenditures, supplies, contracted services and debt service as appropriated from the unappropriated, unencumbered 2018 balances of certain City funds as listed in Section 1 of Ordinance 12861/19 passed on April 10, 2019 as said funds were inadvertently listed in error in Section 1; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Water Pollution Control section of Section 1 of Ordinance No. 12861/19 passed on April 10, 2019 as follows:

703-450-530-000	Contracted Services	\$200,000.00
703-450-590-000	Debt Service	\$333,988.00

is hereby repealed.

Section 2: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that this repeal Ordinance is necessary for the continued daily operation of the affected department. WHEREFORE, this Ordinance shall go into immediate effect.
