**THE FOLLOWING LEGISLATION WAS PASSED BY THE COUNCIL OF THE CITY OF WARREN AND SIGNED BY THE MAYOR ON THE 24<sup>TH</sup> DAY OF MAY, 2017.**

3680	4616/17	A resolution for the purpose, on behalf of the City of Warren, of rejecting the recommendations issued by the Fact Finder in Case No. 2016-MED-10-1085 before the State of Ohio (in the matter of IAFF, Local 204 and the City of Warren), and declaring an emergency.
3683	4617/17	A resolution for the purpose of opposing Ohio House Bill 178 and Ohio Senate Bill 128's First Energy Corporation Nuclear Bailout, and declaring an emergency.
3684	4618/17	A resolution for the purpose of recommending and endorsing patient relief of Ohio in granting of their application through the Ohio Department of Commerce in the construction of a state of the art cultivation and growing facility to be located within the city of Warren, Ohio, and declaring an emergency.

3676	12717/17	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to advertise for bids and enter into contract(s) for the 2017 local/CDBG Road Project, and declaring an emergency.
3677	12718/17	An ordinance for the purpose of appropriating from the unappropriated unencumbered 2016 balances of certain city funds; transferring within certain city funds; and appropriating from the unappropriated, anticipated revenue of various city funds and declaring an emergency.
3678	12719/17	An ordinance for the purpose of authorizing the payment of specific orders or contracts upon receipt of certification of the Fiscal Officer of the sufficiency of funds for said expenditures, and declaring an emergency.
3682	12720/17	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety, for and on behalf of the City of Warren, to apply for Federal Funds programmed by the Eastgate Regional Council of Governments to evaluate and improve the city traffic signal system, and declaring an emergency.
3660A2	12721/17	An ordinance for the purpose of repealing Chapter 927 of Part 9 ("Garbage and Rubbish Collection") and re-enacting Chapter 927 of the Codified Ordinances of the City of Warren, and declaring an emergency.

## **FAILED**

3664 FORTE An ordinance for the purpose of authorizing the Mayor and Director of Public Service and Safety to advertise for bids and enter into a contract for the Management, operations and parking enforcement services of the Franklin Street Parking Deck and various parking facilities within the Central Business District of the City of Warren, and declaring an emergency.

## **FIRST READING**

3681 COLBERT An ordinance for the purpose of amending the proper sheets of the Use District Map accompanying Chapter 1133 of the Planning and Zoning Code of the Codified Ordinances of the City of Warren, Ohio by rezoning the property known as 2841 Niles Road, S.E., Parcel No. 38-661210 from “Residential A” to “Commercial B”, and declaring an emergency.

**Public Hearing June 28, 2017**

3685 FORTE An ordinance declaring the improvement to real property within the City to be a public purpose; exempting one hundred percent of the value of such improvement from real property taxation for a period of thirty years; requiring the owners of such property to make annual service payment in lieu of taxes during the period of exemption authorizing the County Treasurer to pay a portion of the service payments in lieu of taxes to the Warren City School District and the Trumbull Career and Technical Center; describing the public infrastructure improvements made or to be made to directly benefit such property; determining that satisfactory provision has been made for the public infrastructure improvement needs of such property; including additional improvements to be made in support of Urban Redevelopment within the city; establishing the downtown public improvement tax increment equivalent fund for the deposit of the service payments; approving related matters; and declaring an emergency.
