

# **SUMMARY OF LEGISLATION**

**THE FOLLOWING LEGISLATION WAS PASSED BY THE COUNCIL OF THE CITY OF WARREN AND SIGNED BY THE MAYOR ON THE 13<sup>TH</sup> DAY OF SEPTEMBER, 2017.**

3714                      4625/17                      A resolution accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Auditor.

3705                      12737/17                      An ordinance for the purpose of authorizing the payment of specific orders or contracts upon receipt of certification of the Fiscal Officer of the sufficiency of funds for said expenditures, and declaring an emergency.

3706                      12738/17                      An ordinance for the purpose of amending section 1338.02(A) of NOVAK Chapter 1338 (“Vacant property registry”) of the Codified Ordinances of the City of Warren, and declaring an emergency.

3707                      12739/17                      An ordinance for the purpose of approving and implementing the collective bargaining agreement between the City of Warren, Ohio and the International Association of Firefighters, Local 204, and declaring an emergency.

3708                      12740/17                      An ordinance for the purpose of authorizing the Mayor and Director of Public Service and Safety to enter into a professional service agreement for the purpose of hiring specialized legal counsel and experts to defend the City of Warren, Ohio in a civil action captioned Freshwater Accountability Project vs. Patriot Water Treatment, LLC and the City of Warren, Ohio and declaring an emergency.

3709                      12741/17                      An ordinance for the purpose of authorizing the Director of Public Service and Safety to advertise for bids and enter into a one year contract(s) or two year contract(s) each with an additional one year renewable clause for the removal and disposal of solid sludge from the centrifuge unit of the City of Warren’s water filtration plant, and declaring an emergency.

- 3710                    12742/17                    An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to advertise for bids and enter into a one year contract(s) or two year contract(s) each with an additional one year renewable clause for the purchase of materials and supplies for the Water Department, and declaring an emergency.
- 3711                    12743/17                    An ordinance for the purpose of authorizing the City of Warren to accept monies, pursuant to the Ohio Revised Code Section 715.01, from the Warren City School District, and to allow said monies to be used for the authorized Municipal purpose of providing five Student Resource Officers and all necessary equipment for said Student Resource Officers for the 2017-2018 school year, and declaring an emergency.
- 3712                    12744/17                    An ordinance for the purpose of approving the annexation of certain territory currently located in Howland Township and consisting of approximately 5.2583 acres of land (commonly known as 962 North Road, NE LTD.) to the City of Warren and declaring an emergency.
- 3713                    12745/17                    An ordinance for the purpose of appropriating from the unappropriated, anticipated 2017 revenue of certain city funds; appropriating from the unappropriated, unencumbered balances of various city funds; transferring with the general fund and declaring an emergency.
- 3715                    12746/17                    An ordinance to revise the Codified Ordinances by adopting current replacement pages and declaring an emergency.
