**THE FOLLOWING LEGISLATION WAS PASSED BY THE COUNCIL OF THE CITY OF WARREN AND SIGNED BY THE MAYOR ON THE 10<sup>TH</sup> DAY OF OCTOBER, 2018.**

3795	12809/18	An ordinance for the purpose of withdrawing Warren City Council's objections to the renewal of liquor permit no. 3479558 relative to the name of Habosky Davidson Enterprises, Inc. DBA Powerhouse Bar and Grill located at 999 Mahoning Avenue and Patio, in the City of Warren, Ohio and declaring an emergency.
3800	12810/18	An ordinance for the purpose of appropriating from the unappropriated, anticipated revenue of various city funds; transferring within the general fund; transferring within certain city funds; appropriating from the balances of certain city funds; and appropriating from the unappropriated, anticipated revenue of the general fund and declaring an emergency.

3785	4638/18	A resolution for the purpose of supporting the efforts of the Warren Municipal Court to create a Medical Assistance Treatment Program to assist individuals with opioid drug issues in the City of Warren, Ohio.
