Job Description

GENERAL STATEMENT OF DUTIES: Performs general heavy manual work; does related work as required.

DISTINGUISHING FEATURES OF THE CLASS: This is routine work consisting of heavy manual tasks. The duties require ability to do heavy physical labor efficiently. Laborer I's work under direction of other employees who lay out the details of each specific assignment, and constantly check the work in process and upon completion.

EXAMPLES OF WORK: (Illustrative Only)

- Cleans gutters, culverts, sewers and other drainage structures;
- Loads and unloads stone, gravel, dirt, asphalt, timber and heavy mechanical equipment;
- Assists in semiskilled work such as plumbing, carpentry, electrical, auto repair or concreting by carrying tools, by carrying or lifting equipment, by mixing or stirring concrete, by replacing light bulbs or by running errands;
- Sweeps streets, gutters and sidewalks by hand;
- Shovels snow, gravel and dirt;
- Mows lawns with hand power and small riding mower;
- Rakes leaves and cuts brush;
- Performs a variety of other heavy manual work in connection with the maintenance and construction of sewers, water mains and parks;
- Drives pick-up truck to and from job or as assigned;
- Dumps screenings, ash, and grit pans at wastewater treatment plant;
- Hoses and cleans pump stations;
- Assists in the flushing of manholes, and removes grit, stones, gravel, brick and other debris;
- Washes and cleans cars and trucks;
- Weeds and waters evergreen and flower beds;
- Moves furniture and equipment as assigned;
- Cleans debris from vacant buildings that belong to the City;
- Hosing of large tanks to clean wastewater;
- Serves as the safety attendant for permit required confined space entries;
- Performs related work as assigned.

REQUIRED KNOWLEDGE, SKILLS AND ABILITIES: Willingness to perform routine heavy manual work; at various times may need to wear a safety harness and enter permit required confined spaces; ability to lift heavy articles; good stamina; ability to understand simple oral instructions; excellent physical condition.
