Overview

The City of Warren Ohio desires to install fencing around the perimeter of the Warren Community Amphitheatre. The fencing should be a commercial grade aluminum fence, or similar material, approximately 4 feet high with a number of man gates and vendor gates as entrance and exit points for visitors and for deliveries to the site. The new fencing should be similar to existing fencing adjacent to City Hall to ensure continuity and preserve the aesthetic appeal of the City's downtown. Estimate approximately **1,900** linear feet.
