## **TITLE**

AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY TO ADVERTISE FOR BIDS AND ENTER INTO COSTS OF REPAIR CONTRACT(S) FOR THE REPLACEMENT OF THE ROOF AT THE WATER DISTRIBUTION AND ENGINEERING, PLANNING AND BUILDING DEPARTMENTS LOCATED AT 540 LAIRD AND DECLARING WARREN, OHIO, AVENUE, EMERGENCY.

ORDINANCE NO. 12 778/18

WHEREAS, the roof of the Water Distribution and the Engineering, Planning and Building Departments located at 540 Laird Avenue in the City of Warren are in a state of disrepair which creates a dangerous situation to both employees and equipment and replacement should be done; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and Director of Public Service and Safety be, and hereby are, authorized to advertise for bids and enter into contract or contracts for the repair and replacement of the roof at the Water Distribution and the Engineering, Planning and Buildings Departments located at 540 Laird Avenue in the City of Warren, Ohio in accordance with plans and specifications therefore on file in the office of the Director of Public Service and Safety. After advertising for bids according to law, the Mayor and the Director of Public Service and Safety are hereby authorized to enter into whatever contracts(s) which may be useful or necessary to accomplish said purpose.

Section 2: That said contract(s) shall be paid for from the proper accounts.

Section 3: That the contract(s) shall be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that the roof to be replaced represents a dangerous condition to employees and equipment and shall be more fully insured at the earliest possible time and without undue delay. WHEREFORE, this ordinance shall take effect and be in force from and after the earliest period allowed by law.
