ORDINANCE FOR THE **PURPOSE** APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED BALANCES OF CERTAIN CITY FUNDS; TRANSFERRING WITHIN THE GENERAL APPROPRIATING **FROM** UNAPPROPRIATED, ANTICIPATED REVENUE OF VARIOUS CITY FUNDS AND APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED REVENUE OF THE GENERAL FUND AND DECLARING EMERGENCY.
