AN ORDINANCE FOR THE PURPOSE OF WITHDRAWING WARREN CITY COUNCIL'S OBJECTIONS TO THE RENEWAL OF LIQUOR PERMIT NO. 3479558 RELATIVE TO THE NAME OF HABOSKY DAVIDSON ENTERPRISES, INC., DBA POWERHOUSE BAR AND GRILL LOCATED AT 999 MAHONING AVENUE AND PATIO, IN THE CITY OF WARREN, OHIO AND DECLARING AN EMERGENCY.

ORDINANCE NO. 12809/18

WHEREAS, the City of Warren has filed an objection with the Ohio Department of Commerce-Division of Liquor Control for the renewal of the liquor permit, Permit #3479558, which is held by Habosky-Davidson Enterprises, Inc., dba Powerhouse Bar and Grill located in the City of Warren, Ohio; and

WHEREAS, said permits are for the business located at 999 Mahoning Avenue and Patio, in the City of Warren, Ohio; and

WHEREAS, the parties believe that the aforementioned objections can be resolved to the mutual satisfaction of the parties; and

WHEREAS, the proposed Agreement, once entered into, would address and resolve the concerns of this Council which gave rise to the aforementioned objections, and would be in the best interests of the City of Warren and its residents; NOW THEREFORE

BE IT RESOLVED by the Council of the City of Warren, State of Ohio:

Section 1: That this Council, for the aforesaid reasons and grounds, hereby withdraws their objection of the renewal of liquor Permit No. 3479558 relative to the name of Habosky Davidson Enterprises, Inc., dba Powerhouse Bar and Grill located at 999 Mahoning Avenue and Patio, in the City of Warren, Ohio.

Section 2: That the Clerk of this Council, be, and hereby is, authorized and directed, for and on behalf of this Council and the City of Warren and with the intent that this Council and the City of Warren be bound thereby, to execute and enter into, with Habosky Davidson Enterprises, Inc., dba Powerhouse Bar and Grill, a written agreement, the terms and conditions of which are hereby approved and authorized by this Council.


Section 3: That the Clerk of this Council be, and hereby is, authorized and directed, for and on behalf of this Council and the City of Warren, to promptly notify the Ohio Division of Liquor Control of the withdrawal of the aforementioned objection.

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety and for the further reason that the integrity of the various neighborhoods throughout the City of Warren may be more fully insured at the earliest period allowed by law. WHEREFORE, this Ordinance shall go into immediate effect.
