AN ORDINANCE FOR THE PURPOSE OF APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2017 BALANCES OF VARIOUS CITY FUNDS AND APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2017 BALANCES IN THE GENERAL FUND AND DECLARING AN EMERGENCY.
