AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND DIRECTOR OF PUBLIC SERVICE AND SAFETY TO IMPLEMENT THE BUDGET REGULATIONS RECOMMENDED BY THE AUDITOR OF THE CITY OF WARREN, OHIO FOR THE TRANSFERS WITHIN THE APPROPRIATIONS OF THE 2019 FISCAL YEAR AND DECLARING AN EMERGENCY.

WHEREAS, the City of Warren Auditor's office supervises the finances, budgets and the appropriations for the City of Warren, Ohio; and

WHEREAS, the office of the Auditor of the City of Warren, Ohio, in keeping with the general accounting principles is recommending the implementation of appropriations for the 2019 Budget of the City of Warren, Ohio; and

WHEREAS, all expenditures during the fiscal year, beginning January 1, 2019 and ending December 31, 2019, shall be made by the Auditors authorized warrants against the appropriations set forth in the budget, upon the presentation of complete and proper vouchers; and

WHEREAS, the transfers shall not exceed the amounts as set forth in the budget or as amended and approved by the Council of the City of Warren for the 2019 fiscal year; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and Director of Public Service and Safety be, and hereby are, authorized to implement the budget regulations recommended by the Auditor of the City of Warren, Ohio for the transfers of the 2019 fiscal year.

Section 2: That the transfers shall not exceed the amounts as set forth in the budget as approved or amended by the Council of the City of Warren for the 2019 fiscal year.

Section 3: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety of the City of Warren at the earliest possible time and without undue delay. WHEREFORE, this Ordinance shall go into immediate effect.
