## **TITLE**

AN ORDINANCE FOR THE PURPOSE OF APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2018 BALANCES OF CERTAIN CITY FUNDS; TRANSFERRING WITHIN VARIOUS CITY FUNDS; AND APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED 2019 REVENUE OF CERTAIN CITY FUNDS AND DECLARING AN EMERGENCY.

WHEREAS, there exists a need to: appropriate from the unappropriated, unencumbered balances of certain City funds, transfer within various City funds and appropriate from the unappropriated, anticipated 2019 revenue of certain City funds.
