ORDINANCE FOR THE **PURPOSE** AN APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED 2019 REVENUE OF VARIOUS CITY FUNDS, TRANSFERRING WITHIN THE GENERAL FUND, TRANSFERRING WITHIN CERTAIN **APPROPRIATING FROM** THE FUNDS, AND UNAPPROPRIATED, **UNENCUMBERED** 2018 BALANCES OF CERTAIN CITY FUNDS **AND** DECLARING AN EMERGENCY.

ORDINANCE NO.

WHEREAS, there exists a need to: appropriate from the unappropriated, anticipated 2019 revenue of various City funds; transfer with the General Fund; transfer within certain City funds and appropriate from the unappropriated, unencumbered 2018 balances of certain City funds to provide for the usual daily operations of the City of Warren.

WHEREAS, this Ordinance constitutes an emergency measure, in part, in that the same provides for the usual daily operation of the municipal departments; NOW **THEREFORE**

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That there be, and hereby is, appropriated from the unappropriated, anticipated 2019 revenue of various City funds, the sums as follows:
