AN **ORDINANCE** FOR THE **PURPOSE** OF APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2018 BALANCES OF VARIOUS CITY FUNDS, TRANSERRING WITHIN CERTAIN FUNDS, AND APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2018 THE GENERAL **FUND** BALANCES OF **AND** DECLARING AN EMERGENCY.

WHEREAS, there exists a need to: appropriate from the unappropriated, unencumbered 2018 balances of various City funds; transfer within certain City funds; and appropriate from the unappropriated, unencumbered 2018 balances of the General Fund to provide for the usual daily operations of the City of Warren.

WHEREAS, this Ordinance constitutes an emergency measure, in part, in that the same provides for the usual daily operation of the municipal departments; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That there be, and hereby is, appropriated from the unappropriated, unencumbered 2018 balances of various City funds, the sums as follows:
