TITLE

AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY TO ADVERTISE FOR BIDS AND ENTER INTO A ONE YEAR CONTRACT(S) OR TWO YEAR CONTRACT(S) EACH WITH AN ADDITIONAL ONE YEAR RENEWABLE CLAUSE FOR THE PURCHASE OF MATERIALS AND SUPPLIES FOR THE WATER DEPARTMENT, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 13059/2021

WHEREAS, it is necessary to maintain certain materials and supplies at a safe operational level for the Water Department for the proper operation of the department; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and Director of Public Service and Safety be, and hereby are, authorized to advertise for bids and enter into a one year contract(s) or two year contract(s) each with an additional one year renewable clause for the purchase of materials and supplies for use in the Water Department, as listed and contained in "Exhibit A" attached hereto and made a part hereof as if fully rewritten, and in accordance with plans and specifications therefor on file in the office of the Director of Public Service and Safety. After advertising for bids according to law, the Mayor and Director of Public Service and Safety are hereby authorized to enter into whatever contract(s) which may be useful or necessary to accomplish said purpose.

Section 2: That said contract(s) shall be paid for from appropriate Water Department Funds as ordered.

Section 3: That the contract(s) shall be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that an early delivery date is necessary in order to maintain chemical supplies at a safe level for proper operation of the department, and to enable the department to coordinate the new contract(s) with the expiration of the old contract(s). WHEREFORE, this Ordinance shall go into immediate effect.
