NATUREWORKS GRANT PROGRAM FOR THE OLD
AVALON GOLF COURSE IMPROVEMENT PROJECT;
AND DECLARING AN EMERGENCY.

RESOLUTION NO. 4678/2021

WHEREAS, the State of Ohio, through the Ohio Department of Natural Resources (ODNR) administers financial assistance for improvement of public outdoor recreational purposes under the State of Ohio NatureWorks Grant Program; and

WHEREAS, the City of Warren, Ohio desires financial assistance under the ODNR NatureWorks Grant Program for Old Avalon Golf Course Improvement Project; NOW THEREFORE

BE IT RESOLVED by the Council of the City of Warren, State of Ohio:

Section 1: That the Council of the City of Warren supports and approves filing an application for financial assistance through the ODNR NatureWorks Program for Old Avalon Golf Course improvements.

Section 2: That the Council of the City of Warren, supports, approves, authorizes and directs the Director of Public Service and Safety to execute and file an application with and through the ODNR and to provide all information and documentation required to become eligible for possible financial assistance for said project.

Section 3: That the Council of the City of Warren, supports the Auditor of the City of Warren to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms of the ODNR NatureWorks Grant Program.

Section 4: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that the City of Warren may timely comply with funding and programming deadlines established by ODNR. WHEREFORE, this Resolution shall of into immediate effect.
