

# SUMMARY OF LEGISLATION

THE FOLLOWING LEGISLATION WAS PASSED BY COUNCIL ON THE 28<sup>TH</sup> DAY OF JULY 2021.

0163	13040/2021	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to advertise for bids, and to thereafter enter into any and all contract(s), for the purchase of one (1) Sutphen Pumper mounted on a custom monarch chassis, and declaring an emergency.
0157	13041/2021	An ordinance for the purpose of authorizing the payment of specific orders or contracts upon receipt of certification of the Fiscal Officer of the sufficiency of funds for said expenditures, and declaring an emergency.
0158	13042/2021	An ordinance for the purpose of transferring within the General Fund and appropriating from the unappropriated, unencumbered 2020 balances of certain city funds and declaring an emergency.
0159	13043/2021	An ordinance providing for the issuance and sale of \$1,435,000 bonds to pay costs of acquiring Sanitation vehicles for the City's Environmental Services Department, together with all necessary appurtenances thereto, repealing ordinance No. 13030-2021 passed by this council on July 14, 2021 in its entirety, and declaring an emergency.
0160	13044/2021	An ordinance for the purpose of repealing and reenacting Section 505.04, "Abandoning Animals." Of the Codified Ordinances of the City of Warren for the purpose of more fully defining the abandonment of dogs, cats and other animals permitted to be kept within the City of Warren, and declaring an emergency.
0161	13045/2021	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety, for and on behalf of the City of Warren, to enter into an agreement with Mercy Health for the purpose of removing inflow and infiltration to offset new sewer flows, to solicit requests for qualifications from Engineering firms, to solicit bids from construction firms and enter into any and all contract(s) necessary to meet any obligations of the agreement and declaring an emergency.
0162	13046/2021	An ordinance authorizing the Mayor and the Director of Public Service and Safety pursuant to section 721.15(C) of the Ohio Revised Code to discard Municipal personal property (including motor vehicles and/or road machinery) that is no longer needed for public use, or is obsolete, unfit for municipal use and has no value, and declaring an emergency.
