0115	13006/2021	An ordinance for the purpose of appropriating from the unappropriated, unencumbered 2020 balances of various city funds; transferring within certain city funds and appropriating from the unappropriated, unencumbered 2020 balances of the general fund, and declaring an emergency.
0116	13007/2021	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety, to accept the Northeast Ohio Public energy Council (NOPEC) 2021 energized community grant(s) fund(s) for providing said funds to assist he City of Warren, Ohio in implementing energy savings, energy infrastructure measures and community energy related projects and declaring an emergency.
