0153	4681/2021	Resolution that the City of Warren will pick up the statutorily required contribution to the Ohio Public Employees Retirement System for the employees of the City of Warren pursuant to Internal Revenue Code Section 414(h)(2).

0149	13030/2021	An ordinance providing for the issuance and sale of \$1,435,000 bonds to pay the costs of acquiring Sanitation vehicles for the City's Environmental Services Department, together with all necessary appurtenances thereto, and declaring an emergency.
0144	13031/2021	An ordinance for the purpose of repealing and reenacting subsection (b)(1) of Section 925.03 ("Charges Levied.") of the Codified Ordinances of the City of Warren, Ohio for the purpose of providing increased sanitary sewer rates for users of the City's sewer system, and declaring an emergency.
0145	13032/2021	An ordinance for the purpose of repealing and reenacting Section 922.08 ("Treatment Charges for septic tank waste.") of the Codified Ordinances of the City of Warren, Ohio for the purpose of providing increased rates for trucked septage, and declaring an emergency.
0150	13033/2021	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety, for and on behalf of the City of Warren, to solicit request(s) from an engineering firm for qualifications and design improvements and enter into any and all contract(s) necessary to obtain funding from the WPCLF (Water Pollution Control Loan Fund) for Phase 2 of the Water Pollution Control Facility Refurbishment Project and declaring an emergency.
0151	13034/2021	An ordinance for the purpose of authorizing the payment of specific orders or contracts upon receipt of certification of the Fiscal Officer of the sufficiency of funds for said expenditures, and declaring an emergency.

| 0134 | 13039/2021 | An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to enter into a cooperative agreement with the Western Reserve Port Authority allowing for the transfer of city owned properties to the Port Authority for the purpose of economic development, and declaring an emergency. |
