

# SUMMARY OF LEGISLATION

THE FOLLOWING LEGISLATION WAS PASSED BY COUNCIL ON THE 23<sup>RD</sup> DAY OF JUNE 2021.

**DRAFT NO.**      **RES. NO.**

**0142**                      **4680/2021**                      A resolution for the purpose of approving and adopting the tax budget for the City of Warren for the year 2022, and declaring an emergency.

**DRAFT NO.**      **ORD. NO.**

**0143**                      **13028/2021**                      An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to advertise for bids and enter into a one-year contract with an additional three-year renewable clause providing for the custodial and cleaning services for various city buildings and departments within the City of Warren, Ohio for the term beginning on August 1, 2021 and ending on July 31, 2022, and declaring an emergency.

**0147**                      **13029/2021**                      An ordinance for the purpose of accepting any eligible funding from the U.S. Department of the Treasury authorized under the American Rescue Plan Act, including but not limited to, reimbursing the City of Warren, Ohio for any revenue losses in any given year from 2020 – 2024 and for any additional expenses incurred related to the Covid-19 Pandemic, and declaring an emergency.

**Draft 0144**                      **LARSON**                      An ordinance for the purpose of repealing and reenacting subsection (b)(1) of Section 925.03 (“Charges Levied.”) of the Codified Ordinances of the City of Warren, Ohio for the purpose of providing increased sanitary sewer rates for users of the City’s sewer system, and declaring an emergency.

**Draft 0145**                      **LARSON**                      An ordinance for the purpose of repealing and reenacting Section 922.08 (“Treatment Charges for septic tank waste.”) of the Codified Ordinances of the City of Warren, Ohio for the purpose of providing increased rates for trucked septage, and declaring an emergency.

**Draft 0146**                      **RUCKER**                      An ordinance for the purpose of repealing and re-enacting Section 927.12 (“Collection Charges.”) of Chapter 927 “Garbage and Rubbish Collection” of the Codified Ordinances of the City of Warren; for the purpose of more fully clarifying said section; and declaring an emergency.

**FIRST READING**

**Draft 0148**      **BROWN**      An ordinance for the purpose of authorizing the payment of specific orders or contracts upon receipt of certification of the Fiscal Officer of the sufficiency of funds for said expenditures, and declaring an emergency.

**SECOND READING**

**Draft 0134**      **WHITE  
SAFFOLD**      An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to enter into a cooperative agreement with the Western Reserve Port Authority allowing for the transfer of city owned properties to the Port Authority for the purpose of economic development, and declaring an emergency.
