PURPOSE ORDINANCE FOR THE AN APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2021 BALANCES OF CERTAIN CITY THE APPROPRIATING FROM **FUNDS**; **UNENCUMBERED** 2021 UNAPPROPRIATED, **FUND:** OF THE GENERAL BALANCES APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED 2022 REVENUE OF THE GENERAL FUND AND DECLARING AN EMERGENCY.

WHEREAS, there exists a need to: appropriate from the unappropriated, unencumbered 2021 balances of certain City Funds, appropriating from the unappropriated, unencumbered 2021 balances of the General Fund, and appropriating from the unappropriated, anticipated 2022 revenue of the General Fund to provide for the usual daily operations of the City of Warren.

WHEREAS, this Ordinance constitutes an emergency measure, in part, in that the same provides for the usual daily operation of the municipal departments; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That there be, and hereby is, appropriated from the unappropriated, unencumbered 2021 balances of certain City Funds, the sums as follows:

Administrative Services 100-250-570-000	Miscellaneous	\$ 500,000.00

Section 3: That there be, and hereby is, appropriated from the unappropriated, anticipated 2022 revenue of the General Fund, the sums as follows:

Operations 100-300-530-000 Contracted Services

\$ 95,000.00

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare, and safety, and for the further reason that the appropriations are necessary for the continued daily operation of the affected departments. WHEREFORE, this Ordinance shall go into immediate effect.
