TITLE

AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY, FOR AND ON BEHALF OF THE CITY OF WARREN, TO ADVERTISE FOR PROPOSALS AND ENTER INTO CONTRACT(S) FOR THE DESIGN AND CONSTRUCTION OF A NATURE PLAYGROUND AT PERKINS PARK.

ORDINANCE NO. 13/15/2022

WHEREAS, Perkins Park, situated within the City of Warren, provides an outdoor recreation space for residents and visitors; and

WHEREAS, there exists a fallen tree in Perkins Park that has the potential to become the Perkins Park Nature Playground for children; and

WHEREAS, the Perkins Park Nature Playground is eligible for the EPA SEP funding disbursed through Eastgate Regional Council of Governments; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

- Section 1: That Warren City Council hereby approves the advertisement for a request for proposals, acceptance of proposals, and entering into a contract(s) for the design and construction of a nature playground at Perkins Park.
- Section 2: That the Mayor and the Director of Public Service and Safety be, and hereby are, authorized, for and on behalf of the City of Warren, to enter into contract(s) for the design and construction of a Nature Playground at Perkins Park.
- Section 3: The City of Warren will seek reimbursement from the EPA SEP settlement funds managed and disbursed by The Eastgate Regional Council of Governments.
- Section 4: That the City of Warren acknowledges and understands this project has been approved by the Ohio EPA and any changes must first be submitted for approval prior to construction.
- Section 5: That it is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were open to the public and in compliance with the law.
- Section 6: That the contract(s) shall first be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.
- Section 7: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare, and safety, and for the further reason that said funding and the proposed project relative thereto may be secured at the earliest possible time and without undue delay. WHEREFORE, this Ordinance shall go into immediate effect.
