## TITLE

**PURPOSE** OF ORDINANCE FOR THE APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2021 BALANCES OF VARIOUS CITY FUNDS; APPROPRIATING FROM UNENCUMBERED UNAPPROPRIATED, 2021 BALANCES OF THE GENERAL FUND; TRANSFERRING WITHIN CERTAIN CITY FUNDS; TRANSFERRING WITHIN THE GENERAL FUND; AND APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED, 2022 CITY FUNDS REVENUE OF CERTAIN DECLARING AN EMERGENCY.
