DRAFT 0317	4698/2022	A resolution for the purpose of confirming the Mayoral appointment of Larry Larson as a member of the Fair Housing Commission of the City of Warren for the term beginning on January 1, 2023 and ending on December 31, 2025 and declaring an emergency.
