A RESOLUTION FOR THE PURPOSE OF: OBJECTING TO THE RENEWAL OF CLASS C1 AND CLASS C2 LIQUOR PERMIT NO. 9904575 HELD IN THE NAME OF AHMMAD OMAR ZAYED, DBA PIT STOP, FOR 1708 YOUNGSTOWN ROAD, S.E., IN THE CITY OF WARREN, OHIO; REQUESTING A COMPLETE HEARING UPON THE ADVISABILITY OF SAID RENEWAL, AND DECLARING AN EMERGENCY.

RESOLUTION NO. 4708/2023

WHEREAS, this Council has been notified by the Ohio Department of Commerce, Division of Liquor Control, of the proposed renewal of Class C1 and C2 Liquor Permit No. 9904575, held in the name of Ahmmad Omar Zayed, dba Pit Stop, for 1708 Youngstown Road, SE, in the City of Warren, Ohio; and

WHEREAS, as to the afore-mentioned permit, this Council finds and concludes {per Section 4303.292(A)(1)(b) of the Ohio Revised Code} that the applicant, or a member, officer, or manager of the applicant, has operated liquor permit businesses in a manner that demonstrates a disregard for the laws, regulations, or local ordinances of the State of Ohio and the City of Warren, Ohio; and

WHEREAS, as to the afore-mentioned permit, this Council finds and concludes {per Section 4303.292(A)(2)(c) of the Ohio Revised Code} that the place for which the liquor permit is sought to be renewed is so located with respect to the neighborhood that substantial interference with public decency, sobriety, peace or good order would result from the renewal of the permit and operation under it by the applicant; and

WHEREAS, Section 4303.271(B) of the O.R.C. provides this Council with the right to object to the renewal of a liquor permit within the City of Warren and the right to request a hearing thereon; NOW THEREFORE

BE IT RESOLVED by the Council of the City of Warren, State of Ohio:

Section 1: That this Council, for the afore-mentioned reasons and grounds, hereby objects to the renewal of Class C1 and C2 liquor permit no. 9904575 held in the name of Ahmmad Omar Zayed dba Pit Stop for 1708 Youngstown, S.E., in the City of Warren, Ohio.

Section 2: That this Council, for the afore-mentioned reasons and grounds and per Section 4303.271(B) of the O.R.C. requests that a complete hearing upon the advisability of the afore-mentioned renewal of the liquor permit in question be held within the City of Warren, the County Seat of Trumbull County, Ohio.

Section 3: That this Council hereby designates the Mayor, the Director of Public Safety and Service, the Director of Law, the Chief of Police, and their designees, to represent this Council and the City of Warren at and for any hearing(s) hereafter held in this matter.

Section 4: That, upon certification by the Law Director, the Clerk of Council shall forward, by U.S. mail, to the Ohio Division of Liquor Control, the following: (a) a certified copy of this Resolution; (b) the afore-mentioned certification by the Director of Law; and (c) a notice that this Council requests the hearing.

Section 5: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare, and safety and for the further reason that the hearing may proceed in a timely fashion. WHEREFORE, this Resolution shall go into immediate effect.
