TITLE

AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY, FOR AND ON BEHALF OF THE CITY OF WARREN, TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACT(S) FOR THE DESIGN, PROJECT MANAGEMENT, AND INSTALLATION OF PUMP REPLACEMENT, INCLUDING BUT NOT LIMITED TO ELECTRICAL WORK, CONTROL PANELS, SPRINKLER BOXES, AND ALL REQUIRED APPURTENANCES THERETO, FOR THE AVALON SOUTH GOLF COURSE, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 13221/2023

WHEREAS, the City of Warren is responsible for the maintenance of the Avalon South Golf Course; and

WHEREAS, the Avalon South Golf Course provides outdoor recreation space for the City's residents and visitors; and

WHEREAS, the Avalon South Golf Course is in need of upgrades, including but not limited to pump replacement, electrical work, control panels sprinkler boxes, and improvements to other appurtenances; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That Warren City Council hereby approves the advertisement for design, bids, project management, installation, and construction of the Avalon South Golf Course upgrades.

Section 2: That the Mayor and the Director of Public Service and Safety be, and hereby are, authorized, for and on behalf of the City of Warren, to enter into contract(s) for the design, project management, installation, and construction of the necessary upgrades for this project.

Section 3: That the agreement shall first be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare, and safety, and for the further reason that said designs, plans, and upgrades relative thereto may be secured at the earliest possible time and without undue delay. WHEREFORE, this Ordinance shall go into immediate effect.
