AN ORDINANCE FOR THE PURPOSE OF APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED REVENUE OF CERTAIN CITY FUNDS, APPROPRIATING THE UNAPPROPRIATED, UNENCUMBERED BALANCES OF THE GENERAL FUND, AND APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED BALANCES OF VARIOUS CITY FUNDS, AND DECLARING AN EMERGENCY.

WHEREAS, there exists a need to appropriate from the unappropriated, anticipated revenue of certain city funds, appropriate from the unappropriated, unencumbered balances of the General fund, and appropriate from the unappropriated, unencumbered balances of various City funds; and

WHEREAS, this Ordinance constitutes an emergency measure, in part, in that the same provides for the usual daily operation of the municipal departments; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That there be, and hereby is, appropriated from the unappropriated, anticipated revenue of certain City funds, the sums as follows:

Section 2: That there be, and hereby is, appropriated from the unappropriated, unencumbered balances of the General Fund, the sums as follows:

Section 3: That there be, and hereby is, appropriated from the unappropriated, unencumbered balances of various City funds, the sums as follows:

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare, and safety, and for the further reason that the appropriations are necessary for the continued daily operation of the affected departments. WHEREFORE, this Ordinance shall go into immediate effect.
